PROGRAM UPDATES

ADULT RESIDENTIAL MODEL

This past year has brought many exciting developments to our two residential homes. Sheila House has undergone a transformation, becoming a Residential Care Facility for the Elderly (RCFE), so our staff can continue to provide the highest quality support to our participants as they age. Kerri, a dedicated caregiver since April of 2009, was recently promoted to Sheila House Administrator, and she will continue to do amazing work in her new leadership role. Maureen House received a well-deserved makeover thanks

to our generous donors. Residents now enjoy a brand new fridge, dishwasher, and even an art table! Both homes recently aced their Quality Assurance inspections, exceeding expectations and earning praise for being a model of excellence for how these types of homes should operate.

SUPPORTED & INDEPENDENT LIVING

This past year, we were thrilled to welcome three new participants into our Independent Living Services (ILS) and two new participants into our Supported Living Services (SLS)! Thanks to our supporters, participants from both programs enjoyed a festive holiday gathering with a delicious meal and gift cards. As always, our participants are active community members. Several of them volunteer at the Food Bank of Contra Costa and Solano, giving back to the community in a meaningful way. With the generous gifts of our supporters, we also hosted a wonderful participant appreciation party last fall. At



this event, we celebrated our participants' attributes, decorated pumpkins, played games, and shared a delicious lunch. We had so much fun celebrating our participants and the community that we have built, where all individuals have the right to lead meaningful, self-determined lives.



PROGRAM UPDATES

ADULT DAY PROGRAM

Our Adult Day Program has seen a wave of positive change this year! Staff have empowered participants by supporting their use of BART, leading to a significant increase in community outings. Participants are gaining confidence navigating public transportation, enjoying trips to baseball games, parks, and museums across the Bay and San Francisco. We are also thrilled to introduce a new Music and Movement class to our 75 participants this upcoming year. Our day program's staffing levels have steadily expanded, and we are optimistic about accommodating up to 90 participants by December.



Our participants have been heavily involved in self-advocacy activities. Many took a stand by advocating against the Governor's proposal to delay funding for critical supports and services for Californians with intellectual and developmental disabilities. Their advocacy efforts, which included protests, marches, and visits to legislative offices at the State Capital in Sacramento, successfully resulted in a six-month delay in funding, rather than the year-long delay proposed by the governor.







PARTICIPANT STORY

Terri's life has changed a lot in the 7 years she's been living with her three Las Trampas roommates on a quaint cul-de-sac in Pleasant Hill. Before she came to Las Trampas, Terri lived for twenty years in Sonoma Developmental Center, initially established in 1891 as an institution for the "feebleminded." Las Trampas Caregiver, Kerri, went to visit Terri in Sonoma and helped her move into Sheila House, one of our two community homes. Kerri remembers the institution as a hospital-like setting. "It was a scary place, with dirty clients walking around aimlessly. There was only one room for clients to hangout in, and they were not encouraged to do anything during the day," shares Kerri.

Now Terri has her own room with a desk and TV, her own space for her belongings, and she has a new glow and lust for life. She loves going to the Concord farmer's market on Tuesdays and dancing at senior centers on Fridays. Terri's brother Mike shares, "It's nice for her to finally be in a house in a nice neighborhood with a backyard (compared to Sonoma which was depressing). It is amazing how clean and orderly the house is."

At Sonoma Developmental Center, the staff warned Kerri about Terri's aggressive behaviors and stealing. But within three months of moving in with her Sheila House family, those behaviors disappeared. The staff at Las Trampas have helped Terri improve her communication skills by asking her questions, and now she can have a conversation instead of just repeating words. Terri is learning to do her own laundry, and she helps with the grocery shopping every week. It's incredible how much progress a person can make when they have the opportunity for choice and community living!

Mike loves that the staff at Las Trampas spend so much one-on-one time with Terri. Kerri shared that most of the staff have been at Sheila House as long as Terri has, and this consistency creates a sense of trust for participants and helps cut down on negative behaviors. They're a family. When everyone in the house (staff and participants alike) had COVID, Las Trampas employee of the year, Cheryl, practically lived at the house and worked 24-hour shifts to make sure the ladies received the care they needed.



Not wanting to break up the family, we've recently transitioned Sheila House into a Residential Care Facility for the Elderly (RCFE). Terri and her friends would have legally aged out of Sheila House at age sixty, and would have needed to find alternate housing. Mike is happy that Las Trampas converted to an RCFE so Terri can continue to live in the home she loves. "It is great to see a problem solved before it needs solving" shared Mike. "People get older, and need a place to go when their parents or siblings can't give them that home life...we found the best for Terri, and we feel very lucky."

DONOR APPRECIATION DINNER

We celebrated the New Year with our most dedicated supporters. We presented the 2024 Spirit of Las Trampas Award to Bob Damaschino and Terry Murray, who were extraordinarily devoted and generous with their time and talent while on our Board of Directors. NAVIGATING TOMORROW SEMINAR

In May, we organized our first seminar on *Navigating Tomorrow: Planning* for Your Child with an Intellectual or Developmental Disability's Future in collaboration with SEED Lafayette. Guest speakers presented on government benefits, estate planning, and financial planning. This event was a huge success, and we look forward to hosting more in the future!



PARTICIPANT NUMBERS BY PROGRAM




LIVING SITUATION OF OUR PARTICIPANTS




